- The complainants have filed this complaint seeking directions from MahaRERA to the respondent to execute the registered agreement for sale with them and also to handover possession of their flat along with interest for the delayed possession under the provisions of section 13 and 18 of the Real Estate (Regulation & Development) Act, 2016 (hereinafter referred to as RERA) in respect of booking of a flat No. 1701, on 17th floor, in Wing-C of the respondent's registered project known as "Rustomjee Azziano Wing-F" bearing MahaRERA registration No. P51700001021 at Thane.
- 2. This complaint was heard on 10-12-2020 as per the Standard Operating Procedure dated 12-06-2020 for hearing of complaints through Video Conferencing. Both the parties have been issued prior intimation of this hearing and they were also informed to file their written submissions, if any. Accordingly, both the parties appeared for the hearing through their respective advocates and made their submissions. After hearing the arguments of both the parties, the directions was given to the

Accordingly, the complainants have uploaded a copy of email dated 19-01-2021 seeking withdrawal of this complaint on record of MahaRERA today. The same is taken on record and accepted.
- 5. Consequently, both the complaints stand dismissed as withdrawn.
