Order

February 18, 2020

- The Complainant has stated that he has purchased an apartment bearing no: 1503-F in the Respondent's project 'EKTA PARKSVILLE PHASE II' situated at Virar, Thane via registered agreement for sale in 2016 (*hereinafter referred to as the said agreement*). The Complainant has stated that the Respondent has failed to handover possession by February, 2019 as stipulated by the said agreement. Therefore, he prayed the Respondent be directed to handover possession of the apartment at the earliest and pay him interest for the delay.
- 2. The authorised representative for the Respondent, explained that the project completion was delayed due to certain mitigating circumstances. Moreover, he submitted that the Part OC for this Project was obtained on May 5, 2019 before the said complaint was filed with MahaRERA. He also submitted that the Respondent has already offered possession to the Complainant.
- 3. Section 18 (1)(a) of the said Act reads as:

Gust r

" if the promoter fails to complete or is unable to give possession of an apartment, plot or building, - (a) in accordance with the terms of the agreement for sale or, as the case may be, duly completed by the date specified therein;

he shall be liable on demand to the allottees, in case the allottee wishes to withdraw from the project, without prejudice to any other remedy available, to return the amount received by him in respect of that apartment, plot, building, as the case may be, with interest at such rate as may be prescribed in this behalf including compensation in the manner as provided under this Act: Provided that where an allottee does not intend to withdraw from the project, he shall be paid, by the promoter, interest for every month of delay, till the handing over of the possession, at such rate as may be prescribed. "

Simple present tense used in the starting line of Section 18 clearly indicated that the provision shall apply only till the project is incomplete or the promoter is unable to give possession. Once the project construction is complete or possession is given, as the case may be, the said provision ceases to operate.

- 4. In view of the above facts, the Respondent is not liable to pay interest on delay to the Complainant, as per section 18 (1) of the Real Estate (Regulation and Development) Act, 2016. The Complainant is advised to take possession of his apartment at the earliest.
- 5. Consequently, the matter is hereby disposed of.
