22. 1.  **Ans:** Embryo Sac (ovule) is the female gamete. It is formed in the ovary. It is fertilized by the male gamete (sperm) which is released from the pollen tube. The fertilization results in the formation of a zygote which develops into an embryo. The embryo is then protected by the ovary wall and the style. The stigma is the part of the flower where the pollen tube enters.

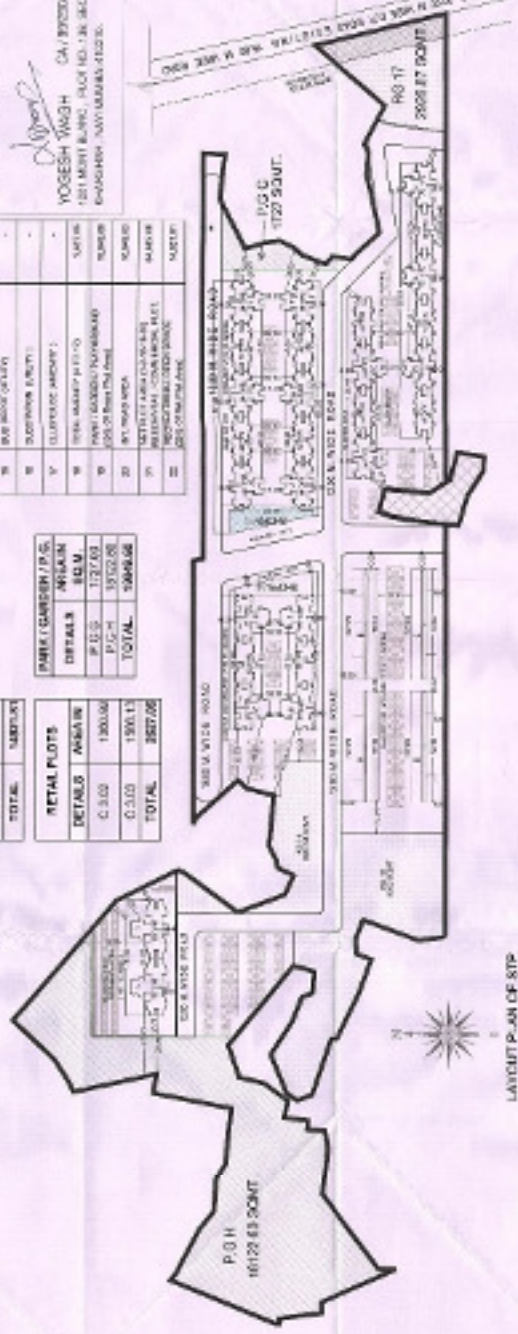
