- 7) The conditions mentioned in D.P. release letter u/no CHE/937/DPBPWS I dated 04 July 2014 shall be complied with.
- 8) Parking proposed for full potential RUT regarding the same shall be submitted.
- 9) That the Civil Aviation NOC shall be submitted.
- 10) That the 1st to 4th upper constructed commercial floors shall be demolished before asking Further CC.
- 11) That all the conditions of D.P. Release letter u/no. Ch.E./937/DPBP/WS I dated 04.07.2014 shall be complied before OCC.
