- 7. The conditions of this certificate shall be binding not only on the applicant but on his heirs, executors, assignees, administrators and successors and every person deriving title through or under him.
- 8. That the work shall be carried out as per the approved plan, Survey remark & all other relevant permissions applicable to this proposal.
