

**PROVISIONS OF THE**  
**CONSTITUTION**  
**ARTICLE I**

**SECTION 1**  
 THE LEGISLATIVE POWER SHALL BE VESTED IN A SENATE AND A HOUSE OF REPRESENTATIVES.

**SECTION 2**  
 THE SENATE SHALL BE COMPOSED OF SENATORS ELECTED BY THE PEOPLE FOR SIX YEAR TERMS.

**SECTION 3**  
 THE HOUSE OF REPRESENTATIVES SHALL BE COMPOSED OF REPRESENTATIVES ELECTED BY THE PEOPLE FOR TWO YEAR TERMS.

**SECTION 4**  
 THE SENATE SHALL BE COMPOSED OF SENATORS ELECTED BY THE PEOPLE FOR SIX YEAR TERMS.

**SECTION 5**  
 THE HOUSE OF REPRESENTATIVES SHALL BE COMPOSED OF REPRESENTATIVES ELECTED BY THE PEOPLE FOR TWO YEAR TERMS.

**ARTICLE II**  
 EXECUTIVE POWER SHALL BE VESTED IN THE GOVERNOR.

**SECTION 1**  
 THE GOVERNOR SHALL BE ELECTED BY THE PEOPLE FOR FOUR YEAR TERMS.

**SECTION 2**  
 THE GOVERNOR SHALL BE COMPELLED TO REMAIN IN OFFICE UNTIL HE OR SHE HAS BEEN SUCCESSFULLY RE-ELECTED OR HAS RESIGNED.

**SECTION 3**  
 THE GOVERNOR SHALL HAVE THE POWER TO VETO ANY BILL PASSED BY THE LEGISLATURE.

**SECTION 4**  
 THE GOVERNOR SHALL HAVE THE POWER TO PARDON OR COMMUTE THE PUNISHMENT OF ANY CRIMINAL OFFENSE.

**ARTICLE III**  
 JUDICIAL POWER SHALL BE VESTED IN THE SUPREME COURT AND IN SUCH COURTS AS THE LEGISLATURE MAY ESTABLISH.

**SECTION 1**  
 THE SUPREME COURT SHALL BE COMPOSED OF JUSTICES ELECTED BY THE PEOPLE FOR SIX YEAR TERMS.

**SECTION 2**  
 THE SUPREME COURT SHALL HAVE THE POWER TO REVIEW AND REVERSE OR AFFIRM THE DECISIONS OF ANY APPELLATE COURT.

**SECTION 3**  
 THE SUPREME COURT SHALL HAVE THE POWER TO REVIEW AND REVERSE OR AFFIRM THE DECISIONS OF ANY TRIAL COURT.

 THE LEGISLATURE SHALL HAVE THE POWER TO TAX AND TO BORROW MONEY.
