- 1. That I/ Promoter has a legal title Report to the land on which the Redevelopment of the project is proposed.

That I/the promoter shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That I/the promoter shall take all the pending approvals on time, from the competent authorities.
- 9. That I/the promoter have/has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
