With reference to your above letter this is to inform you that the above plans, submitted by you are hereby approved subject to following conditions:

- 1) That all the conditions of IOD under even number CE/9233/WS/AK dated 14.12.2007 shall be complied with.
- 2) That all the conditions of Amended plan under even No. dated 19.12.2008, 07.02.2009, 20.08.2010, 20.01.2011, 20.5.2011, 04.10.2011, 04.10.2011, 15.04.2013, 23.07.2015, 19.03.2016 and 12.08.2016 respectively shall be applicable and complied with.
- 3) That Structural Stability Certificate from Structural Engineer shall be submitted for extension/additional floors.
- 4) That the regulation No.45 and 46 of D.C.Reg.1991 shall be complied with.
- 5) That the revised R.C.C. drawing/designs, calculations shall be submitted through Licensed Structural Engineer.
- 6) That the condition of revised bye-law 4[c] shall be complied with.
- 7) That the N.O.C. from Airport Authority of India shall be submitted.
- 8) That the Janata Insurance Policy in the name of site under reference shall be submitted.
- 9) That all the payments shall be made.

- 10) That the C.C. shall be got re-endorsed.
- 11) That extra water and sewerage charges will not be paid to A.E.W.W. K/E Ward before C.C.
- 12) That "All Dues Clearance Certificate" related to H.E.'s dept. from the concerned A.E.W.W. [K/East Ward] shall be submitted before applying for C.C.
- 13) That the revalidation of D.P. permission shall be done before asking for reendorsement of C.C. /F.C.C.
- 14) That the verification of AMSL of completed work shall be done before F.C.C. The AMSL of the topmost part of the building under reference shall also be verified before O.C.C.
- 15) That the sanitary arrangement shall be carried out as per Municipal specifications and drainage layout approved by Ch.Eng. (S.P.) will be submitted before C.C. and completion certificate shall be also submitted from Ch.Eng. (S.P.).
- 16) That the layout u/no. CHE/WS/0558/K/302 (NEW) shall be amended.
- 17) That the dry and wet garbage shall not be separated and the wet garbage generated in the building shall treated separately on the same plot by the residents / occupants of the building in the jurisdiction of M.C.G.M. The necessary condition in Sale Agreement to that effect shall be incorporated by the Developer/Owner."
- 18) That the work shall be carried out between 6.00 am to 10.00 p.m. only (as per Circular No.ChE/DP/7749/Gen dated 07.06.2016
- 19) That the letter from owner stating that no outstanding assessment with payment receipts of assessment tax.
