## TITLE REPORT AND CERTIFICATE

Re:- Pieces or parcels of N.A. Land bearing Survey No.112/4 and Khate No.272, admeasuring 99 Gunthas, situate, lying and being at Village Taloje Majkur, Taluka Panvel, District Raigad.

- Under instructions from our client Mr.Vikrant Vikas Raikar, the Owner of the above property we have investigated our client's title to the above property.
- For the purpose of investigation of title to the above property our client produced the Revenue Records and copies of Sale Deeds, Rectification Deeds, Joint Declarations and N.A. Order dated 11.06.2015.
- 3. It appears from the Revenue Records produced by our client for perusal and investigation that prior to 1978 agricultural land belonging to Smt.Babi Taya Jadhav and Mr.Taya Krishna Jadhav at their original native village were acquired for Koyana Dam Project.

- 4. Taya Krishna Jadhav died intestate in or about 1974 leaving behind him surviving his widow Smt.Babi Taya Jadhav, his four sons namely, Jagannath Taya Jadhav, Raghunath Taya Jadhav, Bhiva Taya Jadhav and Ananda alias Anant Taya Jadhav and two married daughters namely Shantabai R.Kamble and Indirabai Shankar Sakpal as his only heirs and next-of-kins according to the Hindu Succession Act by which he was governed.
- It appears from the Mutation Entry No.982 that in or about 1978 the land bearing Survey No.112, Hissa No.9 admeasuring 45 Gunthas at Village Taloje Majkur, Taluka Panvel, District Raigad and the land bearing Survey No.112, Hissas No.10, admeasuring 72 gunthas at Village Taloje Majkur, Taluka Panvel, District Raigad were allotted to Babi Taya Jadhav and Shri.Jagannath Taya Jadhav son of Taya Krishna Jadhav respectively being Koyna Dam Project affected persons in lieu of their respective lands acquired for Koyna Dam Project and Mutation Entry being Mutation Entry No.982 was effected in that behalf showing the land bearing Survey No.112, Hissa No.9, admeasuring 45 Gunthas, in the name of Smt.Babi Taya Jadhav and Survey No.112, Hissa No.10, admeasuring 72 Gunthas in the name of Mr.Taya Krishna Jadhav.
- Smt.Babi widow of Taya Krishna Jadhav died intestate in or about 1982, leaving behind her surviving four sons namely, (1) Jagannath Taya Jadhav, (2) Bhiva Taya Jadhav, (3) Raghunath Taya

Jadhav and (4) Ananda alias Anant Taya Jadhav and two married daughters namely (5) Indirabai Shankar Sakpal and (6) Shantabai Ramchandra Kamble as her only heirs and next-of-kins according to the Hindu Succession Act by which she was governed.

- 7. In or about 16th April, 1985 by Mutation Entry No.1097 the names of the heirs and legal representatives of Smt.Babi Taya Jadhav namely, four sons Jagannath Taya Jadhav, Bhiva Taya Jadhav, Raghunath Taya Jadhav and Ananda alias Anant Taya Jadhav and two married daughters namely Indirabai Shankar Sakpal and Shantabai Ramchandra Kamble were brought on record in the Revenue Records in respect of Survey No.112, Hissa No.9.
- 8. It further appears that upon the death of Taya Krishna Jadhav the land bearing Survey No.112, Hissa No.10, admeasuring 72 Gunthas was orally partitioned in four equal shares i.e. 18 Gunthas each allotted to the four sons of Taya Krishna Jadhav namely, (1) Jagannath Taya Jadhav, (2) Raghunath Taya Jadhav, (3) Bhiva Taya Jadhav and (4) Ananda alias Anant Taya Jadhav and they were separately cultivating the same.
- 9. It further appears that since 1983, the land bearing Survey No.112, Hissa No.10 admeasuring 72 Gunthas was under the cultivation of four sons of Taya Krishna Jadhav in equal proportionate as follows:-

It further appears from the Mutation Entry No.1322 that Ananda alias Anant Taya Jadhav died intestate in or about 4th January, 1989, leaving behind him surviving his widow Smt.Sunanda Ananda Jadhav, three sons namely, Vinod Ananda Jadhav, Pramod Ananda Jadhav and Rahul Ananda Jadhav and one married daughter Mrs.Pravina Suresh Sakpal as his only heirs and next-of-kins according to the Hindu Succession Act by which he was governed. By Mutation Entry No.1322 the names of the heirs and legal representatives of Ananda Taya Jadhav were brought on record in the Revenue Records.
- 12. It further appears from the Mutation Entry No.1307 that Shri.Jagannath Taya Jadhav died intestate in or about 1st June, 2003 leaving behind him surviving his widow Smt.Krishnabai Jagannath Jadhav and two married daughters Mrs.Anjana Shrihari Sonawane and Mrs.Yamuna Shivaji Kamble and one unmarried daughter Miss.Rajani Jagannath Jadhav as his only heirs and next-of-kins according to the Hindu Succession Act by which he was governed. By Mutation Entry No.1307 dated 1st August, 2006 the names of the heirs and legal representatives of Jagannath Taya Jadhav were brought on record in the Revenue Records.
- 13. It further appears from the Mutation Entry No.1323 that Smt.Indirabai wife of Shankar Sakharam Sakpal died intestate on 8th October, 2003 leaving behind her surviving her four sons namely, Shrirang Shankar Sakpal, Ashok Shankar Sakpal, Suresh Shankar Sakpal, Pramod Shankar Sakpal and three married daughters namely Mrs.Kamal Ramchandra Chavan, Mrs.Vimal Sambhaji Kadam and Mrs.Shobha Ashok Kadam as her only heirs and next-of-kins according

to the Hindu Succession Act by which she was governed. By Mutation Entry No.1323 dated 13th November, 2006 the names of the heirs and legal representatives of Smt.Indirabai widow of Shankar Sakharam Sakpal were brought on record in the Revenue Records.

- 14. We have been informed that Shri.Bajirao son of Raghunath Taya Jadhav died intestate in or about 20th August, 2004 leaving behind him surviving his father Raghunath Taya Jadhav and his mother Mrs.Ranjana Raghunath Jadhav, his widow Smt.Vaishali Bajirao Jadhav, two sons namely, Nitin Bajirao Jadhav and Mayur Bajirao Jadhav as his only heirs and next-of-kins according to the Hindu Succession Act, by which he was governed.
- 15. We have been further informed that Shri.Sunil son of Raghunath Taya Jadhav died intestate in or about 24th July, 2010 leaving behind him surviving his father Raghunath Taya Jadhav, his mother Mrs.Ranjana Raghunath Jadhav, his widow Smt.Vandana Sunil Jadhav, his daughter Sonali Sunil Jadhav and son Kalpak Sunil Jadhav as his only heirs and next-of-kins according to the Hindu Succession Act by which he was governed.
