

**REPORT ON TITLE**

**Re: Property comprised in land bearing various Gut Numbers and admeasurements lying being and situated at Village Gahunje Taluka Maval and District Pune as described in Schedule hereto.**

1. On the instructions of my Clients Sahajanand Hi-Tech Constructions Private Limited (formerly known as Parasnath Hi-Tech Constructions Private Limited) ("the said Company"), I have investigated their title to the land mentioned in Schedule hereunder written.
2. For the said purpose, I have perused
  - a) 7/12 extract and 6/12 extract of the said land
  - b) Title documents viz. Deed of Conveyance, Deed of Exchange, Development Agreement and Power of Attorney including ancillary documents in connection with the said land.
  - c) Non-Agriculture Permission issued by Collector of Pune.
  - d) Name Change Certificate.
  - e) Deed of Mortgage
3. On perusal thereof, I found that the land owners mentioned in Column "A" are entitled to their respective land mentioned in Column "C", "D" mentioned against their names in Schedule hereto, by inheritance, acquisition or otherwise.
4. The said landholders and/or their assigns have entered into their separate and individual transactions of absolute sale and assignment and/or conferring development rights in favour of Parasnath Hi-Tech Constructions Private Limited, Mr. Mangal Prabhat Lodha and Mr. Abhishek Mangal Prabhat Lodha (hereinafter referred to as the said Purchasers/Developers), in respect of their respective land as mentioned in Schedules therein which is the same land mentioned in Column "C" and "D" in Schedule hereto.
5. In the premises aforesaid, I confirm and certify the following:
  - (a) The devolution of title of respective landholders to the respective Land, mentioned in the column "C", "D" of Schedule hereunder written, is satisfactory and who have sold and conveyed and/or conferred development rights (as the case may be) to Parasnath Hi-Tech Constructions Private Limited / Mr. Mangal Prabhat

Lodha / Mr. Abhishek Mangal Prabhat Lodha, in respect of their respective land. There is no right, title or interest adversely affecting the Said Land, being duly conveyed and/or granted development rights to the respective Purchasers/Developers.

(b) Pursuant to the diverse Deeds of Conveyance and/or Development Agreement, the said Land mentioned in column "C" and "D" in Schedule hereto, are in physical possession of the said Company, Mr. Mangal Prabhat Lodha, Mr. Abhishek Mangal Prabhat Lodha, as the case may be, since from the respective dates of purchase/acquiring development rights, the Purchasers/Developers are in quiet, vacant and peaceful possession of the same.

(c) That the Land are freehold private lands and there have been no change in the tenure of the Land.

6. Subsequently, by Declaration dated 1<sup>st</sup> September, 2009 executed by Shri. Mangal Prabhat Lodha, inter alia declared and confirmed that for all intent and purposes, he had purchased and/or agreed to purchase and acquire right, title and interest in respect of the said lands more particularly described in Schedule thereunder written corresponding Land reflected in Schedule hereunder written, for and on behalf of and at the instance of Parasnath Hi-Tech Constructions Private Limited (Purchaser/Developer) to be developed by them as they think fit and proper at their sole discretion and deal with the said land or constructed area thereon accordingly.
7. It is represented that the additional land acquired by Mr. Mangal Prabhat Lodha and Mr. Abhishek Mangal Prabhat Lodha will also execute identical declaration as mentioned in preceding clause for the purpose of development of their respective land through the said Company.
8. Furthermore, under Order Nos. (i) PMA/NA/SR243/2011 dated 24/10/2011, (ii) PMA/NA/SR224/2012 dated 24/11/2012, (iii) PMA/NA/SR204/2013 dated 23/06/2013 and (iv) PMA/NA/SR572/2013 dated 19/05/2014 issued by Collector of Pune, the land indicated by (\*) in Column "C" of Schedule hereto have been converted for non-agricultural use.
9. It is noteworthy to state that the name of Parasnath Hi-Tech Constructions Private Limited has been changed to Sahajanand Hi-Tech Constructions Private Limited pursuant to the Certificate dated

15<sup>th</sup> October 2010 issued under section 23 (1) of Companies Act, 1956 by the Registrar of Companies.

10. By a Deed of Mortgage dated 27/08/2013 executed and registered under No.LVL-3491/2013 with the Sub-Registrar of Assurances at Lonavala by Sahajanand Hi-Tech Constructions Private Limited as Mortgagor/Borrower No.1 and Mangal Prabhat Lodha as Mortgagor No.2 of the One Part and Bank of Baroda as the Mortgagee of the Other Part, the said Mortgagors have inter alia taken credit facilities on the security of their respective land indicated by (\$) in the Schedule hereunder written on terms, covenants and conditions stated therein.
11. On the basis of the findings included in this Report and subject to aforesaid mortgage, on relying upon the representation, I hereby certify that Sahajanand Hi-Tech Constructions Private Limited (formerly known as Parasnath Hi-Tech Constructions Private Limited) (Company) are entitled to carry out development of the land mentioned in Schedule hereunder written as Owners and/or Developers.


