## TITLE CERTIFICATE

- 2) It seems that the said Ashabai V. Wagle had constructed a bungalow consisting of Ground + One upper floor vide permit No.231 dated 28/8/1965 issued by erstwhile Thane Borough Municipality; and, therefore, the said Municipality had issued an Occupation Certificate bearing No.1300 dated 29/11/1967. Thereafter, the part occupation certificate was obtained for the first floor.
- 3) It is seems that Smt. Ashabai Vyankatesh wagle expired on 7/2/1987 at Thane and her husband Vyankatesh Govind Wagle expired on 25/2/1974 at Thane, leaving behind them two sons, namely Shri Milind Vyankatesh Wagle and Shri Anil Vyankatesh Wagle as the only heirs and legal representatives to succeed their property.
- 4) It seems that the names of said Shri Milind Vyankatesh Wagle and Shri Anil Vyankatesh Wagle have been recorded in property card extract.
- It seems that Shri Anil Vyankatesh Wagle expired on 27/9/2009 at Thane, leaving behind him his wife Sheela Anil Wagle and son, namely Gururaj Anil Wagle as the only heirs and legal representatives to succeed the share in the said property of said Shri Anil Vyankatesh Wagle.
- 6) It seems that Shri Milind Vyankatesh Wagle expired on 13/7/2010 at Thane, leaving behind him his wife Medha Milind Wagle, two sons, namely Vyankatesh Milind Wagle and Gunjan Milind Wagle as the only heirs and legal representatives to succeed the share in the said property of said Shri Mlind Vyankatesh Wagle.
